B. Academic Concentrations for Early Childhood Education Majors (30-33 cr.):

In addition to completing Saint Rose's Liberal Education requirements, all Early Childhood Education students must fulfill the requirements for an academic concentration to comply with New York State teacher certification regulations.

Notes for The College of Saint Rose & Hudson Valley Community College Early Childhood Education Agreement:

- 1. Since EDUC 110 covers a broader age range than ECE 230, the content of ECCE 226 and 227 are needed to ensure that the students have the foundational knowledge for Early Childhood.
- 2. Students who take EDUC 225 will be required to take a one credit literacy course at The College of Saint Rose, which will include 10 hours field experience.
- 3. All student teaching credit must be completed at The College of Saint Rose. All field experience courses at Hudson Valley Community College will transfer to The College of Saint Rose as Education Elective credit.
- 4. The combination of EDUC 100 and ECCE 227 will allow the faculty at The College of Saint Rose to waive the Child Abuse Education requirement. However, this is contingent upon Hudson Valley Community College issuing a State Education Department approved "Certificate of Completion" FOR "Coursework/Training in Identification and Reporting of Child Abuse and Maltreatment" to the student upon completion of EDUC 100 and ECCE 227.
- 5. Substance Abuse requirement may be fulfilled by EPY 337 Substance Abuse Workshop (0) or EPY 352 Drug Use & Abuse.
- 6. The combination of ECCE 122 and ECCE 227 will allow the faculty at The College of Saint Rose to waive the HIV/AIDS Education requirement.
- 7. 62 is the maximum number of credits allowed for transfer into Saint Rose. All possible electives are listed in this agreement and the student, along with his/her advisor, should select the most appropriate courses to complete his/her degree at Hudson Valley Community College while not unnecessarily exceeding the number of credits required for the A.A.S. degree.
- 8. A letter grade of C- or higher in each course is required for transfer to The College of Saint Rose. Any completed coursework with a grade lower than C- will not be transferred.
- 9. This document is valid until the time which either party changes their respective programs. At which point review/revision will be required.
- 10. The College of Saint Rose Transfer Equivalency Database and Catalog should be consulted to ensure that selected coursework will fulfill the appropriate Liberal Education Requirements as designated by the "LO" nest to the course credits.
- 11. The Transfer Equivalency Database is the most current tool to utilize when determining the transferability of credits into The College of Saint Rose. The Transfer Equivalency Database can be accessed by visiting the link below:
