Change In Income Disclaimer

The King understands that the challenges brought on by COVID-19 may have impacted your family's current income. You need to file the 2024 - 2025 FAFSA using your 2022 federal tax information. However, after filing the FAFSA, you can contact the financial aid offices of where you are applying to discuss your options. You may need to submit additional information to reflect the changes in your family's income, and they may be able to adjust your financial information on the FAFSA to secure you additional funding.

- Go to www.studentaid.gov and click on the Start Here box to start FAFSA correction or view SAR.
- Update College list by adding a federal school code, income information or other information as needed.

UPDATE TAP APPLICATION (New York State Students Only)

- Go to **www.hesc.ny.gov**, click on **Student Access**, at top right of page.
- Make selection from the account menu and enter HESCPIN User ID,
- TAP PIN and last four digits of your SSN.
- You may review or change your TAP information, change TAP college code or update email address, etc.


